

Envelopes for this and other AAUW Funds will be passed at the business meetings. Suggested contributions are \$15 per year. If you can't remember whether you've given this year, perhaps giving in your birthday month would be easy to remember.

The Legal Advocacy Fund works to challenge sex discrimination in higher education and the workplace. Its resources range from community outreach programs to legal referrals and backing of major cases.



As you know, sex discrimination today takes a variety of forms: unfair pay, pregnancy discrimination, sexual harassment, sexual assault, and violations of Title IX of the Education Amendments of 1972 can affect both women and men. LAF addresses these barriers by informing people of their rights and using the legal system to seek justice and change.

One part of the Legal Advocacy Fund provides Case Support.

The Legal Advocacy Fund (LAF) provides financial and organizational support for a select number of cases in the workplace and in academia that have the potential to provide significant protection for all women.

#### This fund provides funding for:

- Court filing fees
- Preparation of briefs, filings, and other case-based costs
- Plaintiff court travel

Someday the Legal Advocacy Fund could provide support for you or your daughter or granddaughter. It's worth giving to.


