So easy, and so effective. And a reminder; June 9 is the deadline for voting on AAUW national bylaw amendments, Please go the AAUW National website auw.org for details and information about voting on the amendments.

An <u>updated version</u> of AAUW's report "**Deeper in Debt: Women and Student Loans**" found that women now hold almost two-thirds (\$890 billion) of the country's \$1.4-trillion student debt. The ever-growing cost of college <u>disproportionately</u>

<u>burdens women</u>, who take on more debt during their education and struggle to pay it back, in part due to the gender pay gap. The Government Accountability

Office <u>accepted</u> a request by Sens. Patty Murray (D-WA) and Tammy Duckworth (D-IL) to study the obstacles parenting students face in completing their degrees.

Duckworth and Murray are co-sponsors of the Child Care Access Means Parents in Schools (CCAMPIS) Reauthorization Act, which would expand access and increase affordability of on-campus childcare for parenting students.

On July 1, we begin our new fiscal year, 2018-2019. We want to take a brief look at the branch highlights of the past year and thank all of you who helped maintain our vitality, progress, and mission.

Our active membership is now at 69, largely due to our fantastic Membership Mixer organized by Jean Keating in January, where we signed up 13 new members. Sadly, Cornelia Spanier passed away in December at the age of 102. Until the end, she was attending Speaker Meetings and Lunch Bunch, making donations for silent auctions, and endowing a \$2000 scholarship to Maui College. Her smiling and generous personality will be missed.

To ensure our branch is meeting our members' needs, the board conducted an electronic survey last spring. Results indicated an overall satisfaction with the current structure, but also that members are open to new ideas.

The **Whale Watch**, our highly successful fundraiser for scholarships for UH Maui College, was led this year by Pat Gotschalk. Sold out again, this very enjoyable event funded three \$2000 scholarships. (Over the past 20 years, we have donated more than \$100,000 in scholarships). Our fundraiser has been featured in AAUW's national Outlook Magazine. (Everyone likes to dream about Maui!) We gave several of our recent graduates free one-year memberships in AAUW through the *Give a Grad a Gift* program.

Our **Speaker Meetings** incorporated our business meetings September through May (except for the December Holiday Party). Coordinated by Program Vice-President Virginia Shaw, the meetings were well attended, with 20 to 40 members and guests attending. Our speakers were closely aligned with AAUW issues — *Title IX at UHMC, Transgender rights, Women's History, American Pioneers of Equality (by our own Carol Hogard), STEM education for girls, and Immigration Law.* Other programs were about hospice care, local women authors and volunteer opportunities in the community. Our field trips to the Nisei Veterans Memorial Center and Kealia National Wildlife Refuge were enlightening and enjoyable.

Our **Book Club** Interest Group, chaired by Dorothy Tolliver, met monthly at members' homes to discuss both fiction and non-fiction books. Over the past year, members read excellent books on diverse themes: Nine *Parts of Desire, The Gentleman from Moscow, The Orchardist, Pachinko, La Rose, The Danish Girl, Hillbilly Elegy, Underground Airlines, and My Beloved World.*

Sara Green chairs the monthly **Lunch Bunch** Interest Group, which explored new island restaurants and provided members with a chance to socialize and discuss issues of mutual interest.

In addition to our educational programming and scholarships, we also gave back to our community with our voices and our time. We participated in the Women's March the last two years and recently helped collect food and money for the Maui Food Bank. At our Holiday Party, we donated gifts and money to the Women Helping Women Shelter.

At the **State and National** levels, we were also active – 5 members attended the Kona State Convention, and 3 members attended the National Convention in Washington DC. Janet did a training presentation at the state convention. Cathy worked on the agenda for the convention and is the AAUW Hawaii State Treasurer. Many of our members participated in the "2 Minute Activist" online to communicate to local and national legislators support for our AAUW mission (Interested? See page 1).

The next **Board meeting** will be held on Sunday, June 10, at 1 PM, at Cathy Thompson's house, 22 Huluhulu Place in Kahului. We will be planning the calendar for the coming year and discussing ways in which we can benefit our community and

continue the success of our branch. We encourage every member to join us there. We need Committee Chairs for Diversity and Inclusion, Public Policy, AAUW Funds, and a Webmaster. IT'S TIME TO RENEW YOUR MEMBERSHIP

Our annual renewal process is open for fiscal year July 1, 2018, to June 30, 2019. If you did not renew when National sent out an email, you may renew as an ongoing member by using the National Website's online method – it's fast and easy!

- Go online to https://www.aauw.org/
- 2. Click "Login" at the top of the page, enter your member id and password, or click "need to register" if it's your first time logging in to the national site. Member ID is in the Directory or in your email verifying your membership in national. (Registering will require a few extra steps, including confirming via email before proceeding.)
- 3. Click on **Member Services Database (MSD)** toward the bottom of the page.
- 4. Click on "Enter the MSD" (green rectangle)
- 5. Click on "Enter Member Services Database"
- 6. Click on "Renew My Membership" at left
- 7. You will be asked to pay dues by credit card (Life Members pay for local and state dues only). The amount is immediately accepted by AAUW National. National will send you an email notification that your renewal was accepted.

Dues this year are \$59 for National, \$10 for State, and \$16 for Branch, for a total of \$85.00.

SCHOLARSHIPS: The awarding of three \$2000 Maui Branch scholarships is the proud accomplishment of all of you who have worked on and supported our annual Whale Watch fundraisers. Janet Walker, Cathy Thompson, and Adah Askew had the pleasure of presenting the scholarship awards and lei at the podium to our three scholarship recipients at the May 1st UH Maui College Scholarship Ceremony. Committee Chair Dorothy Tolliver and committee members Elizabeth Rogers and Janet Go, who participated in the selection work, were unable to attend.

This year our **Heritage Scholarship** was named in memory of Cornelia Spanier and was awarded to **Vanessa Chavez**. Vanessa, a nursing student in her second year, with outstanding grades and exceptional instructor recommendations, wrote to us and said, "Thank you for your generosity and support; it means the world to me. The program is challenging and at times stressful...I draw strength from you... and some of my financial stresses are alleviated".

Marnie Meuser, now in her sophomore year, received our **Dorothy Shimer Scholarship**. Marnie was a recipient last year and continues doing outstanding work in her studies. She told us how happy she is to have been hired for the permanent position at the Kealia Wildlife Refuge. She will continue working toward her degree part-time while working full time.

Lingli Arakaki, recipient of the **Haines Scholarship** and one of last year's recipients, just received her AA degree in Liberal Arts and will receive a free one-year membership in AAUW through the "Give-a-Grad-a-Gift" program. She reports she will pursue a BA degree in Interdisciplinary Studies from UH Manoa (distance learning program) with a focus on Sustainability and Translation/Interpretation.

HIGHLIGHTS FROM THE MAY 26th SPEAKER MEETING: Maui immigration lawyer **Kevin Block** (left, below) gave a topical and important talk on immigration law. For those who missed the presentation, Kevin provided this short summary:



Immigration 101: Asylum in the age of Trump

The first step in assisting someone is to determine their status, i.e. citizen, lawful permanent resident, temporary visa holder or undocumented. In Hawaii, we also have many "COFA" residents who are citizens of Federated States of Micronesia, the Marshall Islands or Palau who are here legally pursuant to the Compact of Free Association.

There are essentially three routes to permanent residence in the U.S.: family-based petitions, employment-based petitions and humanitarian relief, which includes Asylum. Asylum law developed in the aftermath of World War II to deal with the forced migration of people fleeing violence and persecution. A person is eligible for Asylum if they fear returning to their country of origin because they will be persecuted based on their race, religion, national origin, political opinion or particular social group.

Under the law, a person presents themselves at a port of entry and requests asylum. The Trump Administration and AG Jeff Sessions have implemented policies that are increasingly hostile to Asylum seekers and go against the traditional practices and international agreements that address refugees. Among these policies is the new practice of treating any entry as a criminal matter. Parents are taken into custody and separated from their children, who then appear in Immigration Court without their parents and often unrepresented. This is done to deter refugees from seeking Asylum at our Southern border. Members who wish to get involved in preventing this practice should contact their congressional representatives, the ACLU, Amnesty International and the Hawaii Coalition for Immigration Reform.

Also at the Speaker Meeting, our branch installed its new officers for the coming year, including our new Vice President for Membership, **Debbie Priest** (right), who replaces Jean Keating. Mahalo to Jean for all her hard work, and welcome to the AAUW Maui Board, Debbie!
