Penny O. Andrews - Women and Wealth



Penny O. Andrews, Financial Advisor, Morgan Stanley will speak on "Women and Wealth."

Penny is a Financial Advisor with Morgan Stanley. She worked for the firm in Florida for 6 years and on Maui for more than a year.

The key to financial success is to teach girls and women about financial matters as early as possible. Generational wealth is not available for most young girls and women, especially minorities. Penny became a financial advisor because as a banker in her twenties she saw how much money was often passed down to

families. Unfortunately, this financial security is not always available for most minorities. Also, the gender pay gap is a challenge for most girls and women. The gender pay gap starts at an early age and women are paid significantly less than men. Many women lack financial literacy skills and confidence. Statistically, women outlive men, and it is estimated that 95% of women will be their family's primary financial decision maker. As a Financial Advisor, Penny's goal is to educate her clients so that when wealth transfers, they are knowledgeable and understand the processes and challenges of financial management.

For the past few years, Maui Ku'ia Chocolates have offered Maui AAUW 40% of the proceeds from selected chocolate products when purchased through our own special webpage on <u>their website</u>. You must purchase through this webpage (or purchase in person mentioning AAUW) in order for us to qualify for the funds. Due to the complications of administering this program, the company has decided to discontinue it at the end of this year. But, Maui AAUW will continue to receive contributions from them in two other ways.

First, **our AAUW chapter will continue to receive 100% of the \$35 registration fee paid by attendees to AAUW designated Weekend Laulima Tastings.** We've received proceeds from two very successful tastings this year and will let you know our dates for next year as soon as we have them. If you have not yet attended one of the tastings, I highly recommend it for you, your friends and family. It is a fascinating look into how the company came about and how cacao is grown and processed on our island. And you get to participate in a guided chocolate tasting on their lovely lanai. Hawai'i Title IX Lawsuit Makes National News

The *New York Times* recently featured <u>an article</u> about Title IX litigation involving high school sport teams in O'ahu. The article is behind a paywall so if you don't have a subscription to the *Times* here is a brief summary. It started with an investigation by the *Honolulu Civil Beat* newsroom about gender disparities at James Campbell High School, which is the largest public high school in the state. According to the *Civil Beat* investigation, the high school's male athletes had their own locker room and facilities, but the female athletes had no facilities so they were forced to carry their gear all day, use restrooms in a Burger King or even hide behind the bleachers to change into their athletic gear. The girl's water polo team had to practice in the ocean rather than having access to a pool, and the girl's soccer teams were forced to wait for field time until late at night when the boy's teams were finished. Also, no coach was provided for the girl's water polo team despite repeated requests so the father of a player had to step in to volunteer. The plaintiffs also allege retaliation by high school administrators and teachers.

In July 2022 the case was certified as a class action. The suit was filed by ACLU of Hawai'i working with a legal aid nonprofit in San Francisco as well as a pro bono team from a major national law firm. The *Times* article also noted that Patsy Mink's daughter, Gwendolyn Mink, is following the case with great interest.
