## **April 2024 Newsletter**



**Co-President Report** 

To those who celebrated Easter and those who will celebrate Passover later in April, our best wishes. Both of these holidays have ancient roots in the celebration of spring, a time of renewal.

AAUW is also in a time of renewal and transition. You probably received a postcard from a Maui Branch member with the caption "A Yes Vote for Open Membership is a Vote For Women and Girls of Hawai'i." National AAUW is lobbying strongly for an amendment to the bylaws to "Open AAUW", meaning that anyone, with or without a college degree, who supports AAUW's mission and goals will be able to become a member. We hope that nationwide the affiliated branches will support this. Opening up the membership is driven by the importance of diversity and inclusion but also, frankly, because membership organizations like AAUW are not thriving nationwide.

The AAUW National Board strongly supports open membership, and it will be beneficial to our branch. In 2021, more than 60% of the voters approved the change. Fewer than 10% of the members voted against it. But, fewer than 25% of the members voted.

This bylaw change requires a 2/3 vote in favor of the amendment. A "yes" vote is an opportunity to honor our stated value of Inclusion. This is so important as diverse, particularly younger, people consider joining us.

Online voting commences on April 3 and will end on May 15. If anyone has questions or concerns about the impact of Open AAUW on our branch, feel free to contact either of us. Let's have a goal of 100% of our branch voting on this important bylaw amendment. You will receive emails from AAUW National when the vote kicks off.

In other news, we are honored to announce that our Maui Branch board membership has increased and we have filled important branch officer positions that were vacant due to resignations. Please join us in welcoming our new Vice President of Programs, Shawna Pabingwit (UH Maui College Title IX Coordinator), Co-Vice Presidents for Membership Yukari Murakami (Deputy Corporation Counsel and former longtime Managing Attorney at Legal Aid) and Bevanne Bowers (Executive Director of Maui Mediation Center and per diem District and Family Court Judge), and Public Policy Interest Group Chair, Sonya Toma (Deputy Prosecuting Attorney for Maui County). Also, we welcome new member, Marceline ("Marci") Burgess

#### The Honorable Bevanne J. Bowers

### **Membership Co-Vice President**

Bevanne J. Bowers was appointed Per Diem Judge in the District and Family Courts of Hawaii's Second Judicial Circuit on December 20, 2021, becoming the first African American female appointed Judge in Maui County, Hawaii. She has served as Executive Director of Maui Mediation Services since May 2015. This 501 (c)(3) nonprofit organization provides alternative dispute resolution, facilitation, and training to residents of Maui, Molokai, and Lanai. An integral part of her professional career has been advocacy, encompassing the legal, social service, and entertainment sectors.



A native of St. Louis, Missouri, Bevanne obtained her undergraduate degree from Southern Illinois University-Edwardsville as a Presidential Scholar and her law degree from the University of Memphis, Cecil C. Humphreys School of Law. She is a past president of the Maui Non Profit Directors Association, a Board member of the Hawaii Alliance of Nonprofit Organizations (HANO), a member of the Maui County Bar Association, the African American Law Association of Hawaii, and a member of the Alpha Kappa Alpha Sorority.

#### Yukari Murakami

Yukari is a Deputy Corporation Counsel for Maui County. She previously served as the Managing Attorney for the Legal Aid Society of Hawaii, overseeing the Maui, Lanai, and Molokai offices. She was first employed at Legal Aid in 2008 as a staff attorney for the Maui office, practicing mainly family law. While at Legal Aid, she represented families as parents' counsel and guardian ad litem for children in Child Welfare cases.

Yukari has been living on Maui since 1993 and graduated from Maui High School in 1997. She obtained her undergraduate degree at Bryn Mawr College in 2001. She graduated from University of Hawai'i William S. Richardson School of Law in 2005.

#### Tail's Up Maui - Freshest fish to be found!

Maui Now shared:

"Tails Up Maui, a restaurant in Paukūkalo, reopened on Jan. 26 after a transformative period of community service. The restaurant, which temporarily closed due to labor shortages one month before the Lahaina fires, found a new purpose by converting its restaurant into a food hub for the houseless community and those displaced by the fires in the months that followed. Tails Up Maui produced more than 450 meals a day, seven days a week, for the houseless community during its closed period. The establishment also provided support to the Lahaina community during Thanksgiving, Christmas, and meeting direct-to-'ohana feeding needs."
